Pakistan's Seminar for Parliamentarians

Congratulations to SPC, the Gobal CRVS Group's new Chair

Following the recent meeting of the Global CRVS Group on 2 March, in New York, the Global CRVS Group elected the Secretariat of the Pacific Community (SPC) as the new Chair to guide the group for the 2020-2021 period. During their tenure, SPC will be tasked with promoting CRVS improvement agendas globally, while maintaining adherence to the Group's central promise to strengthen national CRVS and related systems through coordination and collaboration on global and regional initiatives and exchange of information.



Kazakhstan amends law to ensure universal civil registration coverage

In good news from Kazakhstan, the Kazakh government recently amended the "Code on Marriage and Family" to ensure that "all children born in the country are registered at birth and issued birth certificates, regardless of the legal status of their parents". UNHCR heralded the Kazakh government's decision saying, "this speedy decision and action" would "prevent children from becoming stateless in the future".

This amendment represents a broader shift in how countries are starting to adapt in order to end-statelessness and follows the widely praised 2019 announcement recognizing Kyrgyzstan as the first country to eliminate all known cases of statelessness.



OpenCRVS goes live in Bangladesh

OpenCRVS is an open-source, digital CRVS system designed for low-resource settings. The system pilot is now live in Bangladesh. The OpenCRVS pilot seeks to prove a model for digital civil registration in Bangladesh that will contribute to sustainable universal registration in the country. Based on extensive design research, OpenCRVS has been configured for the Bangladesh context and takes civil registration services to the community through the use of a mobile application used by Community Health Assistants.

The pilot is being conducted in 2 locations, one rural and one peri-urban, and will last 12 months. The focus of the project is to test, learn and change the model on a continuous basis in order to understand and document the most cost effective and efficient model for birth and death registration at scale.

OpenCRVS is now available as a digital public good. See <u>github.com/opencrvs</u> for source-code and info on how to deploy, configure and customize for specific country context. Designed for low resource settings, OpenCRVS provides governments with a user-centric, rights-based and fully interoperable civil registration solution that can be deployed, operated and maintained by local teams.

ESCAP's Statistics Director raises awareness for the Ministerial Conference in October

In an effort to raise awareness for the upcoming Ministerial Conference in October, ESCAP's Statistics Director, Gemma Van Halderen, recently attended both "Connecting Vital Events Registration and Gender Equality" (ConVERGE) in Ottawa, as well as the 51st Statistical Commission in NY. During each event, Ms. Van Halderen emphasized the progress being made in Asia-Pacific, as well as the remaining challenges and expected outcomes for the Ministerial Conference.

ConVERGE, hosted by the <u>Centre of Excellence</u> for CRVS Systems, UNFPA and <u>Open Data Watch</u>, assessed global progress being made in meeting gender-related targets and focused discussions on

using CRVS systems to integrate gender analysis across CRVS improvement activities.

The 51st Statistical Commission focused its CRVS discussions heavily on civil registration as a foundation for legal identity, as well as using data generated from CRVS systems to measure the progress of SDG indicators. Civil registration was also discussed under the agenda item on health statistics.



CRVS highlighted as foundational to a holistic legal identity agenda

In addition to discussing the role of CRVS in generating accurate and timely public health statistics, CRVS systems also played a prominent role among the member states in <u>discussing national</u> <u>approaches</u> to a holistic legal identity agenda.

Chief Statisticians attending the intergovernmental forum discussed the <u>United Nations Legal Identity Agenda</u> which builds on the existing methodological framework for CRVS as developed under the auspices of the International Programme for Accelerating the Improvement of CRVS Systems and expands it to ensure a holistic and interoperable approach between civil registration, vital statistics production and identity management.
